## BOYD-EKWURZEL CEMETERY (by Thomas Ray)

Members of the Pintlala Historical Association visited the Boyd-Ekwurzel Cemetery on April 20, 1997. This cemetery is located just off Duncan Road near Sprague, Alabama. It is situated on land that was originally the home place of two of the early settlers in this county, Walter and Letitia Bussey Boyd. The property was later acquired by their daughter and son-in-law, Sarah Lyon Boyd Ekwurzel and Otto Gustav Ekwurzel. Both couples are among those buried there.

Walter Boyd, the son of Edmund and Susannah Thurmond Boyd, was born in Edgefield, SC on December 3, 1796, during the presidency of George Washington. Letitia Bussey Boyd, the daughter of Dempsey and Sarah Lyon Bussey, was also born in Edgefield, SC, on May 8, 1800.

Walter and Letitia Bussey Boyd were married in 1818 South Carolina, and came to Montgomery County in 1822. They are parents of 16 children. Walter was one of the founders of the Bethlehem Primitive Baptist Church. He was a successful farmer and served for a time as Justice of the Peace. Walter Boyd died January 29, 1844. Letitia Bussey Boyd married Thomas Butler, owner of the grist mill on Pintlala Creek, on October 15, 1845. After Thomas Butler's death in 1855, Letitia returned to the old home place that she and Walter Boyd had established. There she resided until her death on April 20, 1864.

Sarah Lyon Boyd Ekwurzel was born April 17, 1840. She married Otto Gustav Ekwurzel, a native of Sweden.

The Ekwurzels were originally from Germany and the German name was Eichwurtzel. Some of them went from Germany to Sweden as German soldiers during the Thirty Years War between Germany and Sweden in the 1600s.

Otto Gustav Ekwurzel, the son of Anders Benjamin and Anna S. Mansdotter Ekwurzel, was born October 18, 1833. Otto Gustav, a sister and several cousins came to the United States on the same ship in 1849. He lived for a while at Washington Court House in Washington County, Alabama. He was later apprenticed to a confectioner in Mobile and then came to Montgomery and opened his own confectionary business. It was at that business that he first met Sarah Lyon Boyd.

In July 1862, he enlisted in Company H of the First Alabama Partisan Rangers. That unit later became the First Alabama Cavalry. He was taken prisoner in August 1863 and was confined in Federal Prison in Camp Morton, Indiana.

He and Sarah Lyon Ekwurzel were parents of 11 children, including seven who are buried in this cemetery.

Otto Gustav Ekwurzel died April 29, 1881. Sarah Lyon Ekwurzel died May 22, 1924, and was the last person buried in this cemetery.

Others buried in this cemetery include Dempsey B. Boyd, a Confederate veteran and the third child of Walter and Letitia; Martha King Boyd, wife of Dempsey B. Boyd; Anna Jackson Boyd, first wife of James Thomas Boyd; and Fannie Smith Boyd, second wife of Walter Boyd who was a grandson of Walter and Letitia.
