CLEAN UP AT BETHEL CEMETERY: by Gary Burton

On Saturday, December 12, the Baptist Men's Organization of the Pintlala Baptist Church spearheaded an effort to clean up the Bethel Cemetery. Located approximately one mile north of the Pintlala intersection on Highway 31, two brick columns garrison the road upon which many once traveled in order to gain entrance to the highway. The date inscribed on the columns is 1818. Many early settlers of the Pintlala community are buried at this long-neglected site.

Doubtless, the cemetery was established in conjunction with the Bethel Baptist Church, a one-time thriving congregation before the great split of 1837. The cemetery still contains a commemorative stone with the words 'Split Between the Primitive and Missionary 1837.' Consequently, the cemetery has both historic and denominational significance for the Pintlala Baptist Church whose roots are in the missionary heritage of the Baptist faith.

Charles Jordan and Bill Bowes, co-directors of the Baptist Men's Organization, worked with Macon Brock, General Manager of "Yards and Stripes" a self-owned and operated company specializing in lawn maintenance. Several others donated their time in order to clear away most of the large undergrowth and prepare it for controlled burning. Other work days will be held soon. NOVEMBER 1987 MEETING: notes from minutes

There were 45 members at the last meeting of the organizational year. The treasurer, Ricky McLaney reported a balance of \$690.53 in the treasury with postage for the newsletter being the major expenditure. Kerry Brown presented to proposed Bylaws which were adopted without dissent. Laurie Sanders will obtain blanks for those interested in registering a Heritage Farm. Among other qualifications it must have been in the same family for 100 years and must be actively farmed. The Dr. Tankersley farm now owned by our president, Ethel Tankersley Todd has been awarded Heritage Farm status. Information to be donated to Association files will be copied at no expense on the new copier. All other copies will be charged at the regular library rate. The president announced efforts to have the county place "Ball Branch" markers where this historic stream crosses Pettus Road. Jim Edwards, Ricky McLaney and Gary Burton were named to a Committee for Preservation and Restoration and are encouraged to work with the statewide Preservation Alliance. Efforts are being made to locate a 4 drawer, fireproof locking cabinet for the Association files, M.M.S.

BYLAWS

Pintlala Historical Association

Adopted November 15,1987

Article I

Membership and Dues

Section I. Any person interested in the history of Southwest Montgomery County including: Hope Hull, McGehee's Switch, Pintlala, Fleta, LeGrand, Snowdoun, Sankey, Mt. Carmel, Devenport, Sellers Station, Sprague Junction, Bethlehem or Tabernacle who applies for membership and pays necessary dues shall become a member.

Section II. Annual dues per family shall be initially \$10.00 and thereafter, \$5.00 per year in advance. Members in arrears more than six months after payment is due shall be dropped from membership.

Article II

Schedule and Quorum for Meetings

- Section 1. Regular meetings of the association shall be held quarterly on the 3rd Sunday beginning in January.
- Section 11. Special meetings may be called by the president.
- Section III. Meetings of Board of Directors shall be held on the 3rd Sunday of March and September. Special meetings may be called by the president.
- Section IV. One-third of active members shall constitute a quorum.

Article III

Duties of Officers and Board of Directors

- Section I. The president shall have executive supervision over the activities of the Association within the scope provided by these bylaws. The president shall preside at all meetings.
- Section 11. The vice-president shall assume the duties of the president in event of absence, incapacity, or resignation of the president.
- Section III. The secretary shall keep minutes of meetings of the Association and of the board of directors and maintain a list of members.
- Section IV. The treasurer shall be responsible for the safekeeping of Association funds and for maintaining adequate financial records. The treasurer will collect dues, pay bills, and render guarterly and annual reports.

Section V. The Board of Directors of the Pintlala Historical Association shall have the power to conduct all affairs of the Association. The board will consist of the president, vice-president, secretary, treasurer, parliamentarian and four members-at-large. Five members shall constitute a quorum.

Section VI. The Board of Directors of the Pintlala Historical Association will serve staggered two year terms. The president, secretary, parliamentarian and members-at-large places 1 and 2 shall be elected at the January meeting of 1989 and blennially thereafter. The Vice-president, treasurer and members-at-large places 3 and 4 shall be elected at the January meeting of 1990 and blennially thereafter. All elections shall be held at the January meetings of the Association unless specially called by the president. A nominating committee shall be appointed by the president at the last meeting preceding an election. No members of the Board of Directors shall serve more than two consecutive terms. If any position on the Board becomes vacant with the exception of president the Board of Directors shall have authority to appoint someone to fill that unexpired term.

Article IV

Committees

Section I. The president shall name such committees as are necessary for the functioning of the Association.

Article V

Parliamentary Authority

Section I. The rules contained in Robert's <u>Rules of Order</u> shall govern the proceedings of the Association except in such cases as are governed by the constitution and bylaws.

Article VI

Amendments to the Bylaws

Section I. These bylaws may be amended at any regular meeting by a two-thirds vote of the membership, provided notice was given at the previous meeting. All proposed amendments shall be submitted in writing.

Historical research is a search for truth about the past. It is an ongoing puzzle where the pieces come from many sources to give us a picture of events, places and people of bygone days. It is our hope that many of us working together can locate and fit together a more complete picture of the life and people of Southwest Montgomery County. In locating pieces of the puzzle it is important that they reflect documented information. Grandpa's stories are fascinating and deserve to be recorded and preserved for future generations but they should only serve as a starting place for the real task of verification.

This is the point at which we turn to the documents - land grant records from the Alabama Tract Book, U.S. Census records, tax records, probate records (deeds, wills, estate papers, marriages), Church and cemetery records, old newspapers, family Bibles, pictures tucked away in old photo albums, old maps - the list is long and we are fortunate to have many of these sources available at the Alabama Archives. Some of them may be on your closet shelf. Those old newspaper clippings, pictures or other mementos may provide the clue that solves a piece of the puzzle for another researcher. Lurline Hall is doing a splendid job of cataloging and indexing the information being donated to our files. M.M.S.
